**The Saudi-led Coalition Airstrikes committed a masscare against civilins in "Bakeel Al Mair".**

**The location:**

A village in Samnah area- Bakeel Al Mair district in the northern side of Hajah province.

**Time:** 6:10 am

**Date:** Thursday May 7, 2015

**Violation type:**

Airstrikes bombing killed one family in an horror way ( Mohamed Nasser family was killed and burned by The Saudi-led Coalition).

**Violators:**

The Saudi-led Coalition: (Saudi Arabia, the UAE, Kuwait, Qatar, Bahrain, Egypt, Sudan, Turkey, Jordan, United States)

**Description of the transgression:**

At 6:00 o'clock on Thursday May 7<sup>th</sup>, 2015 The Saudi-led coalition airstrikes bombed a village in Bakeel Al Mair – Hajah province, the bombing targeted a bunch of simple houses belong to civilians, whole family was killed contains (13) members most of them children and women. The only survivor from the incident is one child and he is now at the Intensive care unit. The survivor was found with his brother outdoors no food to eat no shelter to sleep at. The airstrikes bombed everything unfortunately; the other brother died 3 hours since they found him. The family used to live a very simple life lacking basic needs of life due to The Saudi war against civilians in Yemen. This family just a sample of many families in Yemen suffering from war and lacking medical supplies.

**Result of the violation:**

The bombing caused the death of 14 civilians from one family among them 6 children and to women, as well, the injury of two children where they waited for almost four hours without aid until they were taken to the capital city of Sanaa to receive aid unfortunately, the elder brother passed away the moment he arrived to the hospital. Few days later the other brother died suffering from his

serious injury. In addition, the bombing caused also the death of 100 cattle and the complete destruction of many houses.

The legal center has documented crimes and damages that were committed by The Saudi-led Coalition by documenting eyewitnesses' statements, Medical reports, and Specialists witnesses.

Hajah province like the other provinces in Yemen lack the basic needs of life due to war and blockade. People are suffering the Saudi-led Coalition airstrikes have mostly destroyed everything, from day to day the security situation is going worse. The Legal Center has documented the miserable live in Hajah province basic needs of life don't exists in most of Hajah districts. Harad hospital also lack from the medical supplies patients' situation is so miserable, the number of injuries is increasing.

The legal center recommendations:

The Legal center considers the violations in Yemen as crimes committed against civilians and Crimes Against Humanity, as well, infraction of human rights and international law.

**Recommendations:**

We urgently call upon international human rights organizations and the United Nations to speed up the work to stop targeting civilians and to stop The Saudi-led airstrikes against Yemen which is against the law and the humanity. As well, we call to relief victims as soon as possible.

The Legal Center call on the international organizations to open an investigation file and to send committees to investigate on these crimes and to bring proprietors to justice.
